I understand that I must contact HAHS first, but that ultimately I will be responsible for this animal. _____ initial

I will provide wholesome food and water; appropriate housing for protection from weather; companionship, affection, exercise, grooming and training as needed; protection from harm; professional veterinary care when needed, including annual veterinarian visits to obtain appropriate shots and preventatives as recommended by the veterinarian. I will comply with applicable laws and regulations relating to animal ownership including a valid rabies tag and owner ID tag.

If I fail to conform with these obligations, I will be in breach of this Agreement and subject to the remedies below. _____ initial

I will not abandon, neglect or abuse the animal or allow others to do so; allow the animal to become a public nuisance or hazard; use or permit others to use the animal in illegal activities; use any chemical or treatment except for those approved by a licensed veterinarian; permit killing of the animal by anyone other than a licensed veterinarian or humane facility; transport or confine the animal in a vehicle in a careless or inhumane manner.

If I fail to conform with these obligations, I will be in breach of this Agreement and subject to the remedies below. _____ initial

I understand that while no animal would be offered for adoption without disclosure of a known medical condition, all veterinary and other expenses incurred after adoption and throughout the lifetime of the animal are my responsibility. _____ initial

I agree I will not have this cat de-clawed, and I agree to house this cat indoors only. _____ initial

I agree I will not have this dog de-barked, tail docked, or ears cropped. _____ initial

HAHS remedies: I acknowledge that HAHS remedies for my breach of this Agreement include,

- HAHS's right to retrieve the adopted animal by entering upon public or private property if necessary.
- Judicial process or any other legal or equitable means to seek return of the animal and to recover all costs of enforcing this Agreement, including court costs and attorneys fees.
- My payment to HAHS the sum of \$400 as liquidated damages. _____ initial

I agree to allow HAHS volunteers to call or visit to assure compliance with this Agreement, and to assist me with questions or concerns. I authorize my vet to release any information regarding this animal to HAHS upon request. _____ initial
